

TERMS AND CONDITIONS - #capturethespirit

1. Information on how to enter and the prize form part of these terms and conditions. Entries not in accordance with these terms are deemed invalid.
2. Participation in the Promotion constitutes acceptance of these terms.
3. To enter the Promotion, the customer must –
 - I. Enter our photo booth, located in between Suncorp Bank and Helloworld Travel.
 - II. Take a 'selfie' photo with our photobooth equipment – camera will count down to take a photo – there will be staff onsite to help you with this.
 - III. Enter all your details in the ipad ie. Name & email address.
 - IV. Send a copy of the photo via email or text to yourself.
 - V. Follow Kenmore Village on Facebook or Instagram.
 - VI. Load their selfie onto their Facebook or Instagram profile.
 - VII. Share the photo with the hashtag #capturethespirit either on Facebook or Instagram to be in the running.

NB. If you have your profile set to private we may not be able to see the entry when we search the hashtag. The entry must be set to 'public' to be valid.

On Facebook you can change the privacy setting of just the one post to 'public'. You don't have to change your whole profile – only the shared post with the hashtag.
